# CONSTANT EFFORT TOWARD STRENGTHENING THE RIGHTS OF CHILDREN, PEOPLE WITH DISABILITIES AND RURAL WOMEN FOR GOING TOWARD INCLUSIVE SOCIETY (2017)

#### I-RECENT HISTORICAL BACKGROUND

From the Paris Peace agreement (23 Oct 1991) implemented by the United Nations Transitional Authorities in Cambodia (UNTAC) solving armed conflict by democratic way and creation of new government by the universal election (23-28 May 1993), Khmer Rouge resumed fighting, boycotted the election of 1993 sponsored by the United Nations Transitional Authority in Cambodia (UNTAC) and, in the following year, rejected its results until their complete surrendering to the government in December 1998, until present time 2016, with successive five democratic elections, Cambodia has not yet full possibility to come satisfactorily out of poverty with enjoyment of universal civil rights. Health and education remain important challenge. Royal government of Cambodia (RGC) succeeded to decrease the proportion of people whose income is less than the national poverty line from 39% to 36% between 1994 and 1999 and to 28% by 2015. According to Action Plan, the RGC planned to reduce the proportion of people living in poverty to ≤19.5%, and hunger to ≤10%; Concerning the access to primary education, the MDG evaluation confirmed significant improvement over the last decade, but the target in term of access to lower-secondary school, Cambodia is unlikely to reach its targets. The human rights situation in Cambodia is facing growing criticisms both within the country and an increasingly alarmed international community. The Rectangular Strategic Plan Phase III in the National Strategic Development updated 2014-2018 continues to maintain Good Governance in the heart core of the plan with 4 principal strategic objectives: 1-Fighting Corruption; 2-Legal and Judicial reform; 3-Public Admiration Reform and 4-Reform of Armed Force.

#### II-CONSTANT EFFORT OF OPERATION ENFANTS DU CAMBODGE (OEC)

Since 1993, many international donors came assisting Cambodia development that allowed OEC to take part in the mission from 1996 and started its first strategic plan 2011 – 2015 supported by UNICEF, Friends International, Adopt-A-Minefield, KHANA/USAID/ Global Fund, and EU/DFID/Handicap International, Safe the Children / IKEA, SCHMITZ STIFTUNGEN, BICE/OAK, MISEREOR, KINDERMISSION- SWERK, USAID through Save the Children, and SVENSKA POSTKOD STIFTELSEN/CMAC.

From 1996 to 2010, OEC ran 13 projects with a total supporting fund of \$3,027,219. In starting its first five-year plan 2011-2015, OEC began to arrange assembling all OEC projects in three main programs to be managed and coordinated as one unit with the objectives of achieving outcomes oriented towards OEC vision (Vision: Children and Cambodian people of all conditions and categories enjoy basic rights for life development, full of hope, security and prosperity). These three programs are Children's Rights Development Program (CRDP), Rural Women Empowerment Program (RWEP) and People with Disabilities and Landmine Victims/ Survivors Empowerment Program (PWD/LVS/P). For accomplishment of the strategic plan 2011-2015, OEC got a total supporting fund of \$2,786,240 for running 12 projects. The Mid-term Review of the strategic plan performed by Management Committee from 15 June to 11 September 2013 recommended OEC to make great effort in the remaining time of strategic plan to raise fund for human rights education in primary and secondary school, respecting World Program for Human Rights Education, especially article 26 of UDHR and to strengthen existing class and student's council for Building Positive Teacher-Student Relationships. Additionally, OEC should also try its best to realize Rural Women Empowerment, respecting article 14 of CEDAW and Cambodian Millennium Development Goal 3: Promote gender equality and empower women and girls.

Later, from January to April 2016, the Management Committee started Self-evaluation of the Strategic Plan 2011-2015 by practicing SWORT analysis of the strategic objectives and the three programs, CRDP, PWD/LVS/P and RWEP. The principal committee of Self-evaluation proposed first the following shortening:

<u>Vision</u>: Children and Cambodian people of all conditions and categories enjoy basic rights for life development, full of hope, security and prosperity.

<u>Mission:</u> To bring local authorities and communities' members in common effort and activities for empowering children, people with disabilities and rural women.

<u>Core Values</u>: We believe and implement strictly the eight principles of Good Governance.

Secondly the committee proposed to implement the General Conclusion of the self-evaluation decided commonly by the staff retreat from 02 to 05/4/16 with regards to real situation of the country, various world programs and donors' trends, mainly to:

- Maintain the precious three programs, CRDP, PWD/LVS/P and RWEP in the next strategic
  plan, because they respond to the real needs of the country and in accordance with the SDG
  referred by international donors;
- Set strategic objectives of the next plan enclosing the three programs, dropping down the others not related to the said programs;
- Shorten Vision, Mission and Core Values of the next strategic plan, but covering a large aspect;
- Design projects respectively to the three main programs

Keeping the above conclusion in mind, OEC starts its first year of its second Strategic Plan 2016 – 2020 with 8 projects supported by: EAC/AEA; SCUK; IKEA; SCHMITZ STIFTUNGEN; KINDERMIS-SIONSWERK; triple sponsor BICE/ OAK/ MISEREOR IHR HILFSWERK / Kinder MISSIONSERK and NOURISH, focusing mainly on inclusive education partially in 9 provinces, scholarship in Sangker and Ek Phnom district and Nutritional status and well-being of women and children in eight districts of Battambang province, which is a part of Women and girls Empowerment. The position of the three Project Managers, presently having not yet international donor to take in charge of admin staff, is honorary and benevolent for the good working train of the organization. To fulfill the gap of its 3 programs, CRDP, PWD/LVS/P and RWEP, OEC has then strong and firm obligation to make great effort to present fundraising for supporting Human Rights Education in primary and secondary school system conformable to the First Phase of World Program for Human Rights Education (2005-2009) decided by Human rights Council, resolution 6/24 on 28 September 2007 and to Cambodian Program listed in the Human Rights Lesson for the Southeast Asian Schools in 2009 (file:///C:/Users/PTC%20Computer/Downloads/Documents/wphre-sea-report.pdf), respecting the principles in article 26/2 of UDHR. Another fundraising will be presented for income Generating Activities of PWD/LVS and poorest people in remote areas and for Empowering Rural Women and girls, as stated in article 14 of CEDAW, SDG5 (Achieve gender equality and empower all women and girls ) and SDG 16 (Promote Peace, Justice and Inclusive Societies) in respecting Cambodian Education Law, in alignment with education strategic plan 2014-2018 and National Plan Education for All 2013-2015; respecting law on the protection and the promotion of the rights of person with disabilities, in alignment with strategic development plan of MOSVY 21014-2018 in alignment with Neary Rattanak IV, Gender Equality and Women's Empowerment 2014-2018.


